## **Chapter Coordinator Newsletter**

## November 2011

Chapter Registration Forms are now in the mail. Please make sure your chapter watches for this important letter from MAFCA. Annual Chapter registration enables MAFCA to have up-to-date Chapter information. This will provide accurate Chapter membership counts for the liability insurance provided by MAFCA, help in communications to the Chapters and provide accurate information for potential new Chapter members.

If your chapter does not return the Chapter Registration Form and becomes inactive, you will need to submit an Annual MAFCA Chapter Registration Renewal Form within 2 years of inactive status. After the 2-year period, a New Chapter Charter Petition application must be filed and your chapter loses its longevity status.

You will also receive a notice to contribute to the Directors and Officers Insurance. MAFCA does not ask for contributions every year for this necessary but costly insurance. However, this fiscal year's budget makes it necessary.

If all of these reasons aren't enough to make sure your chapter's registration is returned, starting in 2012, there will be a Late Fee of \$10 charged to chapters failing to return their registration by February 28<sup>th</sup>. It pays to renew early to retain your chapter insurance and save the registration fee.

Nothing is as constant as change. Changes can be good or bad but usually necessary. You will notice that the Chapter Listing will no longer be in every issue of *The Restorer* Magazine. Starting in 2012, the complete listing will only be published once yearly in the April/May issue. This will give *The Restorer* editor more room for technical articles, human interest, member articles and other Model A related items. The complete chapter list can always be found on the MAFCA website – click on CHAPTERS and then CHAPTER LIST.

Your MAFCA dues notices were sent out a couple of months ago. I hope you have all sent in your 2012 dues. If not, please get this in the mail before the Christmas shopping season eats up your funds. You wouldn't want to miss out on any issues of *The Restorer* Magazine. Speaking about Christmas, check out the MAFCA Store on the website. There are a number of items that will make wonderful gifts for Christmas. There is a new MAFCA water bottle, perfect for traveling and you won't fill up landfills with plastic bottles. There is also a MAFCA blanket that I am going to order too. Besides, shopping is easy on the MAFCA website.

If your chapter is planning on awarding someone the MAFCA Service Award, e-mail me the forms as soon as possible. I need to have the forms in my hands by November 1st in order to have them ready for signatures at the December board meeting. E-mail them directly to me or get them in the mail directly to my home as soon as possible to avoid delays. If the office receives them, they then need to forward them on to me which all takes time.

Awards have been finalized for MAFCA Newsletter Awards and MAFCA Website Awards for 2011. It has become necessary to revise the website award policy for future years. Due to the fact that chapters submit their requests but fail to send in changes to their web addresses, the job has become very intensive. Starting with 2012, chapters must submit a request each year for award consideration. With each request, the chapter

must submit the web site address, Webmaster name, and Webmaster email address. The reason for having the Webmaster name and his/her email address is to provide a means of feedback to the Webmaster. This year, many broken links were found and bad CONTACT US pages that wouldn't allow a contact to the chapter for verification.
