This should include when the project was started, scope of the project, condition of the car when started, progress to date, type of assistance received, major challenges and how they were overcome as well as the targeted completion date. Include least 3 photographs and dates taken. Also include one good photo of the youth for the magazines.

Application must be postmarked no later than <u>June 15, 2010.</u>

QUALIFICATIONS and RULES:

The award is open to all sons/daughters, grandsons/granddaughters of members of MAFCA and MARC.

- B. The applicants shall be between 12 and 21 years of age.
- C. The applicant must possess and be in the process of restoring a Model A or AA Ford.
- D. The restoration activity must be directed toward completing a Blue Ribbon/Fine Point or Touring Class Model A Ford. Help can be provided.
- E. Proof of ownership, date and how acquired must be provided.
- F. The restoration shall be intended for personal use (not for resale or by contract for another individual).
- G. Modified or Hot-Rod projects are not eligible for consideration.
- H. You must keep your receipts for parts purchased with the funds awarded to you. These receipts must be sent to the award program to continue receiving funds from the program.
- I. Club president must certify project.

The Grant amount awarded to all applicants is determined by the amount donated by the participating MAFCA/MARC Clubs, individual donors and Model A Vendors divided by the number of applicants
